The PTSA Senior Events Committee, the parents responsible for planning this event, is committed to keeping it safe, drug and alcohol free, and will take all reasonable steps to ensure that the conduct of all seniors is in keeping with this goal. All participants will be subject to a pat down before entering the facilities.

The graduate (if over 18 years of age) and their parent or legal guardian assume all risks associated with the attendance and participation at the graduation party and agree to hold each member of the PTSA Senior Events Committee, West Coast Entertainment and its officers, employees, contractors and entertainers harmless from any and all liability claims of any nature which may arise in connection with the event. Furthermore, the graduation party is not a school sponsored event and Issaquah High School assumes no legal liability associated with the event.

Any graduate who engages in prohibited behavior including possessing or being under the influence of tobacco, drugs or alcohol, or engages in other undesirable conduct will be, at the sole discretion of the PTSA Senior Events Committee, removed from the event. If this should occur, the parent(s) will be called and required to pick up the graduate from the party venue. No refunds will be granted. The graduate (if over 18 years of age) and their parent or guardian are liable for the full replacement cost of any and all loss or damage to any persons or property that is directly or indirectly caused by the graduate.

In case of emergency, authorization is given for all medical, surgical, diagnostic and hospital procedures as may be deemed necessary and performed by a treating physician. The graduate (if over 18 years of age) and/or their parent or guardian assumes responsibility for any expenses incurred as a result of accident, injury, illness and/or unforeseen circumstances requiring treatment. Any medication required by the graduate must be given to the designated person at check-in, along with a parental note with instructions for administration.
